RATE UPDATE FOR DHSS-AUTHORIZED HOME AND COMMUNITY-BASED SERVICES

Applies to: Providers of DHSS-Approved Home and Community-Based Services

Effective date: July 1, 2025

- **RATE UPDATE FOR THE FOLLOWING PROGRAMS:**
 - **AGED AND DISABLED WAIVER (ADW)**
 - **STRUCTURED FAMILY CAREGIVING WAIVER (SFCW)**

MAXIMUM ALLOWABLE RATE INCREASE

Effective for dates of services on or after July 1, 2025, the MO HealthNet Fee-For-Service maximum allowable rates are increased as indicated below. These changes reflect increases that were appropriated for the Fiscal Year 2026 budget.

MO HealthNet will reimburse the lower of the provider's billed charge or the maximum allowable amount for the date of service billed.

The affected procedure codes and amounts are as follows:

Program/Service	Procedure Code	June 30, 2025 Maximum Rate	July 1, 2025 Maximum Rate
Aged & Disabled Waiver – Home Delivered Meals	S5170	\$6.21	\$6.71
Structured Family Caregiving Waiver – Attendant Care Service	S5126 HB	\$92.09	\$103.80

APPLICABILITY

The information in this bulletin applies to the MO HealthNet (MHD) fee-for-service program and may apply to the MHD managed care program, as well. MHD's fee-for-service policies set the basic coverage policies for benefits and limitations in the managed care program. The managed care health plans have additional flexibilities in operating their respective programs such as determining which services require prior authorization, and details required for claims submission. Certain services, such as pharmacy, are "carved out" of managed care and will be paid through the fee-for-service program.
