Subject: IHC Qualified Individual, Qualified Entity, and Qualified Trainer Memo
(Course Information Updated)

The purpose of this memo is to provide information on qualified individuals, qualified entities, and qualified trainers, and to provide a list of approved QEs and the required modules needed to complete caregiver and medication training.

Qualified Trainer

1. What is a qualified trainer?

Oregon Administrative Rule [\(OAR\) 333-536-0005\(38\)](#): A "qualified trainer" means an individual who:

(a) Has completed an Authority approved training program; or

(b) Is designated by an agency to conduct caregiver training on behalf of the agency, including but not limited to agency specific orientation, initial caregiver training and annual caregiver training required by these rules, and meets the following criteria:

(A) Has two or more years of experience working with an agency, a long-term care facility as defined under ORS 442.015, a residential care facility as defined under ORS 443.400, or other health care setting; and

(B) If the designated individual is a caregiver, the individual must be current with the caregiver training requirements under these rules.

2. Are there Authority approved training programs for qualified trainer under OAR 333-536-0005(38)(a)?

At this time there are no Authority approved training programs to become a qualified trainer to provide caregiver training.

3. Can a qualified trainer conduct orientation?

Yes, a qualified trainer can conduct agency specific orientation.

1. Can a qualified trainer conduct medication training?

No, a qualified trainer cannot conduct medication training listed in OAR 333-536-0070(8).

Qualified Individual

1. What is a qualified individual?

Oregon Administrative Rule [\(OAR\) 333-536-0005\(37\)](#): A "qualified individual" means an individual who:

- a) Has completed an Authority approved training program (there is no approved training program at this time); or
- b) Is currently a Licensed Independent Practitioner (LIP), registered nurse (RN), licensed practical nurse (LPN), physician assistant (PA), or pharmacist; or,
- c) Is another health care professional, not listed in subsection (36)(b), who has been approved by the Authority to conduct training.

2. Are there Authority approved training programs for qualified individuals under OAR 333-536-0005(37)(a)?

At this time there are no Authority approved training programs to become a qualified individual to provide caregiver or medication training.

3. How do I become an Authority approved training program under OAR 333-536-0005(37)(a)?

Requests to become an approved training program for qualified individuals must be submitted to the IHC program. The request must include:

- a) A written request for approval of the training program; and,

- b) The curriculum, written materials, or login information (in the case of online training) so that the training program can be reviewed.

4. How does a health care professional, as described in OAR 333-536-0005(37)(c), obtain approval by the Authority to conduct training?

Requests to become an approved Healthcare Professional by the Authority to conduct training must be submitted to the IHC program. Requests must include:

- a) A written request for approval of a health care professional to conduct training, including the applicant's healthcare degree, certificate or licensure, resume, and information on the appropriateness of the applicant to conduct caregiver or medication training;
- b) Details that specify if you are requesting caregiver training, medication training, or both training; and,
- c) The applicant's resume.

5. How long does it take to become an approved qualified individual under OAR 333-536-0005(37)(a) or and approved health care professional under OAR 333-536-0005(37)(c)?

The length of the approval process for these requests will vary depending on the accuracy and completeness of submitted materials. Approval requests are part of the general workload of requests for initial licensure, license renewals, and requests for changes to existing licensed entities. All requests are tracked, and work is completed in the order in which it is received.

Qualified Entity

1. What is a qualified entity?

Oregon Administrative Rule (OAR) 333-536-0005(36): A "qualified entity" means an entity whose training program has been approved by the Authority. A qualified entity can provide caregiver training, medication training, or both.

2. How do I become an approved Authority qualified entity to provide training?

For caregiver and medication training requests, submit the following to the IHC program:

- a) A written request for approval of the training program, indicating which training type(s) are being requested; and,

- b) The curriculum, written materials, or login information (for online training) so that the training program can be reviewed.

If it is determined that the program is compliant with the applicable OARs, the entity will receive formal written notification of approval.

Complete documentation includes, but is not limited to:

- c) Compliance with caregiver training topics listed in [OAR 333-536-0070](#)(7) (A-N) and/or medication training topics listed in [OAR 333-536-0075](#)(8);
- d) Compliance with competency evaluation process and documentation listed in OAR 333-536-0075(6);
- e) Compliance with training documentation listed in OAR 333-536-0070(9); and,
- f) Availability of login information for training curriculum.

Failure to submit complete and accurate information will affect the timeline for the qualified entity approval process. Orientation topics are agency specific and are not included in the qualified entity process.

3. How long does it take to become an approved qualified entity?

The length of the approval process for these requests will vary depending on the accuracy and completeness of the submitted materials. Approval requests are part of the general workload of requests for initial licensure, license renewals, and requests for changes to existing licensed entities. All requests are tracked, and work is completed in the order in which it is received.

4. Can a QE conduct the return demonstration competency evaluation for medication training?

No. Per OAR 333-536-0070(8)(b), agencies who use a Qualified Entity for caregiver medication training must still include documentation of the caregiver demonstrating appropriate and safe techniques in the provision of medication tasks described in the rule. These techniques must be evaluated by a qualified individual through a successful return demonstration, documented as required in OAR 333-536-0070(9)(e), and kept in the caregiver record. Qualified Entities cannot provide and are not approved for the caregiver medication training return demonstration competency evaluation.

List of Qualified Entities (QE)

For the caregiver to be compliantly trained, they must complete all the modules included in the QE Class Modules listed below. If the QE program is longer than 8 hours, the entire program still must be completed before a caregiver is compliantly trained. QE courses cannot be mixed between entities, the entire program must be completed for each QE.

Approved QEs, the type of training they are approved for, and the individual modules required to complete training are listed below.

Relias Learning
