Legend

EVV Proprietary System: An HHSC-approved EVV system that a program provider or Financial Management Services Agency (FMSA) may opt to use instead of an EVV vendor system from the state vendor pool.

Approved for Proprietary System Business Rules Version: The version of the HHSC EVV Business Rules for Proprietary Systems that HHSC last used to validate the functionality of the Approved Proprietary System.

Agency Model: The Approved Proprietary System supports the agency service delivery model.

Consumer Directed Services: The Approved Proprietary System supports the Consumer Directed Services (CDS) delivery model.

Landline: The Approved Proprietary System uses a Member's home landline for clocking in and clocking out.

Mobile: The Approved Proprietary System uses a mobile application for clocking in and clocking out.

Alternative Device: The Approved Proprietary System uses an alternative device/method for clocking in and clocking out.

Geo-Perimeter Limit: The EVV allowed geo-perimeter is within 250-1320 feet (1/4 mile) of the member's home.

Daily Fixed: A Schedule Type feature in the Approved Proprietary System that a System User may choose to plan Member Service visits.

Daily Variable: A Schedule Type feature in the Approved Proprietary System that a System User may choose to plan Member Service visits.

Weekly Variable: A Schedule Type feature in the Approved Proprietary System that a System User may choose to plan Member Service visits.

Alternate: A Schedule Type feature defined by the PSO in the Approved Proprietary System that a System User may choose to plan Member Service visits.

Visit Maintenance: Identifies whether legacy EVV visits can be imported for correction after the 95 day period.
